- The restricted stock units were granted July 16, 2018 and vest in four equal annual installments beginning on July 16, 2019.
- The restricted stock units were granted July 16, 2018 and vest in one installment on July 16, 2020.
- Each restricted stock unit represents a contingent right to receive one share of TESARO common stock.
